August 2017 Meeting Minutes – Northwest Skyraiders (Model Airplane Club)

Mike Potter called the meeting to order at 8:00. Mike asked for the Secretary / Treasurer's report. Steve Holt noted the balances in the savings and checking accounts for the club. He noted that he wrote two checks this month, including one to Dave Gardner refunding him for expenses for the contest and one to Bill Darkow for the contest porta-potty and paint supplies. One deposit for dues was deposited this month. Steve noted that 30 members have now paid their dues as of the July meeting.

He has visited the site and finds it to be flat, clean and clear of obstacles with room for a couple of circles. Newcastle May creek Park Site along SE 95th Way —Rob Wyman, the City Manager is coordinating with Puget Sound Energy to determine whether PSE will use the site for staging of power poles and equipment during the "Energize Eastside "project. PSE is conducting soil density testing and may not use the whole site. They may be willing to share the site with our needs per Rob Wyman. Rob owes us a response to determine next steps on the site. Steve makes contact regularly, but PSE is not moving very quickly on this project, so we remain in limbo for this site. Mike Potter discussed the results from the 2017 Northwest Regional Contest held in Eugene, Oregon. He received a Shareholders' report from Mike Hazel noting that the contest costs exceeded the income. Mike Potter proposed after some discussion that the club send a check for \$500.00 to Mike Hazel to help them cover their shortfall for the event. The vote carried and Steve Holt (Treasurer) will write a check and send it to Mike Hazel.

Dave talked about the Ringmaster Event provisionally planned for the weekend of September 30th and October 1st. A location needs to be firmed up.

A short discussion about the Fall Swap Meet scheduling and whether we want to revise the time of year we hold each swap meet. Dave Gardner noted that Flying Lines has a placeholder for us for December 2nd at the Clover Park Aviation Paint Hangar. Mike Potter will not be able to secure the site for our use this year, so a new location flyer needs to be prepared and posted.

Howard Rush spoke about the R.F. Stevenson Memorial Raider Roundup 2017 Contest and discussed which events will be held. He has prepared sanctioning documentation and our insurance is paid up for the year. The Contest is scheduled for September 16th and 17th at the Chehalis – Centralia, WA Airport flying site.

The group held a discussion about fun flying locations and Steve Holt offered to update and send out the list of contact information once again for the club to be able to get in touch with each other to go flying.

Mike Potter asked for any new business.

Mike adjourned the meeting until next month. The next meeting will be held on September 12th (2nd Tuesday of the month). As Steve will be out of town next month, Mike Potter and Dave Gardner will keep notes for minutes next month.
